- Company type: U.S. LLC
- Economic activity: Airbnb property rentals
- **Suggested location:** Florida (with support from Cervera Real Estate)
- **Operational structure:** General Director (*investor*), 1 administrative assistant (*W-2*), who may be the investor's spouse. External operating company (*Airbnb Management 8% sales commission*)

In this model, both the investor and their spouse can self-employ within the business, fulfilling the E-2 visa requirements, while the spouse also retains the option to work outside the business if desired. This maximizes operational efficiency and increases profitability without losing immigration flexibility. G&A Group and the operator handle everything in a daily basis: the model is fully turnkey.

Although the properties are in Florida, the investor's family can live anywhere in the U.S.
