STAGE 1: STRATEGIC EVALUATION

- Analysis of the project's legal and financial feasibility.
- Definition of fund type (LP or LLC) and jurisdiction.
- Preliminary business model proposal (equity, guaranteed rent, debt, etc.).
- CAPEX (capital expenditure) estimates and tentative returns.
- Identification of the ideal investor profile in the United States

Deliverable: Feasibility document + structural roadmap for the fund.

STAGE 2: LEGAL, TAX, AND COMMERCIAL PLANNING

- Definition of the fund's institutional narrative.
- Brand and identity manual (without visual execution).
- Initial drafting of the PPM (Private Placement Memorandum).
- Term Sheet and draft Operating Agreement.
- Coordination with U.S. attorneys (external fees paid by the client).
- Manual for website design, investment deck, and visual branding.

Deliverable: Institutional kit + implementation guide.

STAGE 3: ACTIVATION AND CAPITAL - RAISING PREPARATION

- Segmentation of a database of potential investors.
- Drafting of Investor Letter and basic presentation.
- Manual for digital investment deck.
- Participation in up to 3 virtual or in-person presentations (without event organization).

Deliverable: Digital deck + basic investment materials.

STAGE 4: CAPITAL RAISING (OPTIONAL)

Service paid separately. Not included in basic MSP REIF 360© Service.

Capital Raise Setup Fee: \$250 USD/hour.

Minimum: 20 hours = \$5,000 USD (non-refundable retainer).

Retainer can be deducted from our 2.5% commission success fee if funding is secured thanks to us.

Events, roadshows, campaigns, or calls for investors are also quoted separately at \$250/hour (minimum= 10 hours plus travel expenses).

Deliverable: Support in negotiations, closings, follow-up, and contracts.

STAGE 5: EXECUTIVE FUND ADMINISTRATION (OPTIONAL)

Management Fee: \$250 USD/hour. Minimum: 20 hours/month = \$5,000 USD.

Fee Includes:

- · Reports to investors.
- Legal/tax coordination.
- Supervision of payments, contracts, and compliance.
- Follow-up meetings (Zoom).
- Updating of institutional materials.
- Support in reinvestments and audits.

This fee is applicable only if:

- There is a maximum of 15 20 active investors.
- No parallel capital-raising is in progress.
- The fund is in the initial or maintenance phase.

Extra management support hours can be negotiated with board members if necessary.

- Graphic design, web development, advertising.
- Travel, lodging, or in-person meetings outside San Antonio, TX.

Spouse Work Permit (EAD)

- Processed after the principal's entry.
- Fees: \$1,500 USD

TN Visas (up to 5)

- Mexican professionals (engineering, law, accounting, architecture, etc.).
- Cost: \$2,500 USD per TN visa

Estimated maximum total migration cost: \$26,500 USD
